In other words, the MB shall have a minimum of two identity certificates, and shall respond as normal to the receipt of a KDM targeted to either identity (as distinguished by the respective RSA key pairs).</i></p> <p><i>One identity certificate shall be published, and the other shall not be published and be reserved for future use as designated by DCI. The reserved certificate shall carry the “RES” role in addition to the roles enumerated by the published certificate.</i></p>
